On November 16, 2020, First Republic Bank (the “Bank”) offered and sold 225,000 shares of the Bank’s common stock, pursuant to the exercise of the underwriters’ option to purchase up to that amount as set forth in Section 2(b) of the Underwriting Agreement, dated November 11, 2020 (the “Underwriting Agreement”), by and among the Bank and BofA Securities, Inc., J.P. Morgan Securities LLC and Morgan Stanley & Co. LLC as the underwriters. The shares were sold at a purchase price of \$130.85 per share, resulting in approximately \$29.44 million in proceeds to the Bank, net of underwriting discounts and commissions. The offering closed on November 18, 2020. A copy of the Underwriting Agreement is attached hereto as Exhibit 1.1 and incorporated herein by reference. The Offering was exempt from registration under the Securities Act of 1933, as amended, pursuant to Section 3(a)(2) thereof because the Offering involved securities issued by a bank.
