## Explanation of Responses

(1) The share amount includes 7 shares acquired in exempt transactions under the First Republic Employee Stock Purchase Plan since the last Form 4 filing on October 18, 2019. (2) Restricted stock units, upon vesting, convert into common stock on a one-for-one basis. (3) 875 shares were withheld (not sold into the market) for the purpose of paying the income tax obligations upon vesting of restricted stock units. (4) The options with respect to the shares of common stock are currently exercisable. (5) Restricted Stock Units are awarded under the Company's Omnibus Award Plan with 2,387 units scheduled to vest on January 22, 2021 and 2022.
